Bill 29, *An Act Respecting Cannabis Control*;

and have made certain progress therein.

Mr. D'Amours gave Notice of Motion 73 that on Thursday, May 16, 2024, he would move the following resolution, seconded by Mr. M. LeBlanc:

WHEREAS New Brunswick firefighters risk their health and lives to protect the members of their communities and expose themselves to carcinogens that considerably increase their risk of developing various types of cancer;

WHEREAS firefighters are particularly exposed to cancer-related risks because of their profession;

WHEREAS New Brunswick is ranked second last among Canadian provinces providing financial coverage to firefighters who have cancer, which is unfair, since these heroes not only risk their lives to protect people, but must also deal with financial difficulties and overcome obstacles to access necessary medical care in the event they are diagnosed with cancer;

WHEREAS New Brunswick does not provide financial coverage for breast cancer, multiple myeloma, prostate cancer, skin cancer, thyroid cancer, ovarian cancer, cervical cancer, pancreatic cancer, and mesothelioma, among others, while many other Canadian provinces do;

WHEREAS it is important to provide New Brunswick firefighters with the necessary financial coverage in the event they are diagnosed with cancer, thereby recognizing their commitment to protecting our communities and their right to adequate health protection;

BE IT THEREFORE RESOLVED that the Legislative Assembly of New Brunswick urge the government to extend financial coverage provided to firefighters to various types of cancer to reflect coverage provided elsewhere in the country.

Pursuant to Notice of Motion 49, Mr. M. LeBlanc moved, seconded by Mr. Legacy:

WHEREAS the efficient and judicious use of taxpayer funds is paramount to responsible governance;

WHEREAS fostering positive and constructive relationships between different levels of government is essential for effective governance and public service delivery;

WHEREAS diverting public funds towards advertising campaigns that target and attack other levels of government undermines the spirit of collaboration and cooperation necessary for addressing societal challenges;

WHEREAS such advertising expenditures can be perceived as partisan and divisive, eroding public trust in the political process and government institutions;

WHEREAS the public interest is best served when government communications focus on informing citizens about policies, services, and initiatives rather than engaging in adversarial messaging against other levels of government;

BE IT THEREFORE RESOLVED that this Legislative Assembly urge the government of New Brunswick to refrain from spending any public funds on advertising campaigns that are directed at other levels of government.

And the question being put, a debate ensued.

And after some time, Mr. Speaker interrupted proceedings and announced that the hour of daily adjournment had arrived.
