Mr. Austin rose on a point of order and submitted that the comments made in the House, specifically the quotation of Joseph Goebbels, by Mr. Arseneau the previous sitting day in relation to the People's Alliance party and to Mr. Austin personally, were unparliamentary. Mr. Speaker ruled the point not well taken, but advised Mr. Arseneau that the comments could be considered to be in poor taste and offered the Member the opportunity to withdraw the comments. The Member declined.

Mr. DeSaulniers, Member for Fredericton-York, laid upon the table of the House a petition urging the government to conduct a study on safety improvements to the five-way intersection in Stanley. (Petition 2)

The Order of the Day being read that the House proceed to take into further consideration the amendment to the proposed Address in answer to Her Honour's speech at the opening of the session,

And the debate continuing, after some time, Hon. Ms. S. Wilson, seconded by Mr. Savoie, moved a sub-amendment:

## **SUB-AMENDMENT**

THAT the amendment to the Motion for an Address in Reply to the Speech from the Throne be amended by adding after the word "province" the following:

"where support does not already exist. We recognize that communities in and around the town of Sussex including the McCully Field and extending southeasterly to the Frederick Brook Shale, where natural gas exploration and production has been safely taking place, on leaseholds, for close to 20 years, have demonstrated their desire to proceed with shale gas development. We urge the government to take necessary steps to respect the wishes of those specific communities".

Mr. Speaker put the question on the proposed sub-amendment and a debate ensued.

And after some time, Mr. Speaker interrupted proceedings and announced that the hour of daily adjournment had arrived.

And then, 6.10 p.m., the House adjourned.
