Prayers.

Mr. Melanson rose on a point of order and submitted that the opposition should be provided with copies of Ministers' Statements. Mr. Savoie spoke on the point of order and advised the House that the government would undertake to provide copies in the future.

Mr. Arseneault rose on a point of order and submitted that the Ministers' Statements were not brief, nor were the contents of the statements without argument, as required by the Standing Rules. Mr. Speaker ruled the points well taken and advised that if a statement was lengthy, unanimous consent should be requested.

Mr. Bourque rose on a point of order and submitted that his copy of a Minister's Statement was only in one official language. Mr. Speaker asked that the statements be provided in both official languages, as a courtesy to all Members.

At the request of Mr. Melanson, it was agreed by unanimous consent that the opposition replies to the Minister's Statement delivered by Hon. Mr. Holland be delayed until later in the day.

Mr. Savoie, Government House Leader, announced that it was the intention of government that the House resume the adjourned debate on the motion for an Address in Reply to the Speech from the Throne; following which Opposition Members' Business would be considered.

The Order of the Day being read that the House proceed to take into further consideration the sub-amendment to the amendment to the proposed Address in answer to Her Honour's speech at the opening of the session,

And the debate continuing,

At 12 p.m. the House recessed. At 1 p.m. the House resumed.

As was agreed by unanimous consent, the House reverted to Statements by Ministers to allow the opposition parties to reply to the statement delivered earlier in the day by Hon. Mr. Holland.

Debate resumed on the sub-amendment to the amendment to the proposed Address in answer to Her Honour's speech at the opening of the session, And the debate continuing, after some time it was on motion of Mr. Savoie, on behalf of the Honourable the Premier, adjourned over.

Pursuant to Notice of Motion 7, Mr. D'Amours moved, seconded by Mr. McKee:

WHEREAS the paramedics' union has identified wages as the primary cause for the current paramedic shortage;

BE IT THEREFORE RESOLVED that this House urge the government to immediately begin talks with the paramedics' union to increase wages for paramedics.

And the question being put, a debate ensued.

And after some time, Hon. Mr. Flemming, seconded by Hon. Mr. Cardy, moved in amendment:

AMENDMENT

That Motion 7 be amended:

In the first whereas clause, by striking out "the primary cause" and substituting "a major contributing factor";

By adding after the first whereas clause the following:

"WHEREAS there are other contributing factors to the current paramedic shortage;"

In the resolution clause, by striking out all the words after "government", and substituting the following:

"to work with the paramedics' union to resolve labour force-related issues, including the issue of paramedic compensation, as contributing factors to the current paramedic shortage".

Mr. Speaker put the question on the proposed amendment.

Mr. Arseneault rose on a point of order and questioned whether the amendment was in order. Mr. Speaker ruled the amendment to be in order.

Debate ensued on the amendment.

And after some time, Mr. D'Amours, seconded by Mr. Arseneault, moved a sub-amendment:

SUB-AMENDMENT

That the amendment to Motion 7 be amended:

By adding at the end of the resolution clause after the word "shortage" the following: ", and the Minister to report back to the House on a potential wage solution by the end of the year 2018".

Mr. Speaker put the question on the proposed sub-amendment and it was defeated on the following recorded division:
