Her Honour the Lieutenant-Governor transmits the *Supplementary Estimates 2017-2018*, *Volume I*, of the sums required for the services of the province, not otherwise provided for, for the year ending March 31, 2018, and in accordance with the provisions of the *Constitution Act*, 1867, recommends these estimates to the House.
