Prayers.

Mr. Speaker interrupted Oral Questions and requested that Mr. Landry refrain from using a prop, which he did.

It was agreed by unanimous consent to allow Mr. Landry to table the following documents: letter entitled *The Carbon Tax: At the Pumps*, to Fuel Distributors and Business Owners, from the Minister of Energy and Resource Development dated May 6, 2019; and a sticker entitled *Federal Carbon Tax: At the Pumps*.

Hon. Mr. Carr laid upon the table of the House a document entitled *We can't afford a carbon tax*.

Mr. Arseneault rose on a point of order and submitted that Hon. Mr. Cardy implied that a certain Member may have engaged in cannabis use. Mr. Savoie spoke on the point of order. Mr. Speaker advised the House that the comment was made in jest, however, if it was the will of the House to no longer allow such comments, he required further direction from the House Leaders.

Mr. Arseneault, Opposition House Leader, gave notice that on Thursday, June 6, 2019, Opposition Members' Business would be considered in the following order: Motion 35 and 51.

Mr. Savoie, Government House Leader, announced that following third reading, it was the intention of government that Bills 35 and 36 be called for second reading; following which the House would resolve itself into a Committee of the Whole to consider Bills 30, 31, 32, 29 and 21.

The following Bill was read a third time:

Bill 33, *An Act Respecting the Public Health Information Solution*.

Ordered that the said Bill does pass.

The Order being read for second reading of Bill 35, *Cooperatives Act*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 35 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 35, *Cooperatives Act*, was read a second time and ordered referred to the Committee of the Whole House.

The Order being read for second reading of Bill 36, *Credit Unions Act*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 36 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 36, *Credit Unions Act*, was read a second time and ordered referred to the Committee of the Whole House.

The House resolved itself into a Committee of the Whole with Mr. C. Chiasson in the chair.

At 12 p.m. the Committee recessed. At 1 p.m. the Committee resumed with Ms. LeBlanc in the chair.

At 1.34 p.m. the Committee recessed. At 1.42 p.m. the Committee resumed.

And after some time, Mr. C. Chiasson resumed the chair.

At 4.50 p.m. the Committee recessed. At 5 p.m. the Committee resumed.

And after some time, Mr. Speaker resumed the chair and Mr. C. Chiasson, the Chair, after requesting that Mr. Speaker revert to Presentations of Committee Reports, reported:

That the Committee had directed that he report the following Bills as agreed to:

Bill 21, *An Act to Amend the New Brunswick Income Tax Act*.

Bill 29, *An Act Respecting Research*.

Bill 30, *An Act Respecting Certain Responsibilities of the Integrity Commissioner and the Ombud*.

Bill 31, *Official Notices Publication Act*.

Bill 32, *An Act to Amend the Enforcement of Money Judgments Act*.

And the Committee asked leave to make a further report.

Pursuant to Standing Rule 78.1, Mr. Speaker put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.

And then, 6 o'clock p.m., the House adjourned.
