## **Point of Order**

During Statements by Members, the Member for Madawaska-la-Vallée arose on a point of order as the Member for Saint John Harbour began to make a statement. His point of order was that Standing Rule 40.1(3) requires that Members be recognized to make statements in the following order:

...the Official Opposition first, followed by other recognized parties in order of the size of their membership in the House and finally the Government and then in rotation, until the time provided in subsection (2) has expired.

Mr. Speaker ruled that Standing Rule 40.1(1) allows the Speaker to recognize any Member, other than a Minister of the Crown, to make a statement, noting that there is no requirement that the Member be from a recognized party. Based upon the provisions of this Standing Rule and the practice set during the last sitting of the House when the Member for Saint John Harbour had been allowed to make statements, Mr. Speaker allowed the said Member to make her statement.

Bill 2, An Act to Amend the Legislative Assembly Act.

Ordered that the said Bill be read the second time at the next sitting.

# **Notices of Motions**

Hon. Mr. Valcourt gave Notice of Motion 1 that on Tuesday, February 13, 1996 he would move the following motion, seconded by Mr. Mockler:

WHEREAS the Legislative Assembly of New Brunswick has jurisdiction over many components of the Canadian social safety net which it discharges in cooperation with the federal government; and

WHEREAS a partial reform of our social safety net that does not proceed from a comprehensive review and assessment of the needs of New Brunswickers and Canadians is not desirable; and

WHEREAS the proposed Employment Insurance reforms of the federal government do not proceed from a comprehensive review of the Canadian social safety net; and

WHEREAS too many New Brunswickers and our total provincial economy will be adversely affected by said proposed changes which will result in individuals and families living below the poverty line;

BE IT RESOLVED THAT the Legislative Assembly of New Brunswick ask the Government of Canada to immediately withdraw that government's proposed reform of the *Unemployment Insurance Act*, and substitute therefore a mechanism whereby the federal and provincial governments would jointly undertake a comprehensive review of the social safety net with the objective of reforming all its components and adapting it to the current needs of all Canadians.

Mr. Robichaud gave Notice of Motion 2 that on Tuesday, February 13, 1996 he would move the following motion, seconded by Mr. Volpé:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House for each of the 1991-92, 1992-93, 1993-94 and 1994-95 fiscal years and for the period between April 1, 1995, and December 31, 1995, an account of all expenditures by the province of New Brunswick (departments, agencies, Crown corporations) for the purchase of out-of-province advertising in the following media: television, radio, newspapers, magazines/journals, and pamphlets.

For each contract/placement: department; title of advertisement (including copies); vendor; vendor selection process (open request for tenders, invitation to tender, direct request for tenders); cost (development, placement).

Mr. Sherwood gave Notice of Motion 3 that on Tuesday, February 13, 1996 he would move the following motion, seconded by Mr. Volpé:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House for each of the fiscal years 1991-92, 1992-93, 1993-94 and 1994-95 and for a period April 1, 1995 to December 31, 1995, the following information on each owner licensed to own and operate video gambling machines in New Brunswick: name of owner/operator; address of owner/operator; number of machines owned and operated; location of machines (address, number of machines and type of facility - convenience store, beverage establishment, clubs, other); gross revenue per location (exclusive of winnings); amount remitted to location owner; amount remitted to Atlantic Lottery Corporation; and amount remitted to Province of New Brunswick

Mr. Volpé gave Notice of Motion 4 that on Tuesday, February 13, 1996 he would move the following resolution, seconded by Mr. Robichaud:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House for each of the 1991-92, 1992-93, 1993-94 and 1994-95 fiscal years and for the period from April 1, 1995, to December 31, 1995, the following information on each industrial project that received any financial contribution from the government of New Brunswick: company name; company location; product or service provided; government assistance from the province of New Brunswick (amount, type, aim, claim conditions); assistance from ACOA (amount, type, aim, claim conditions); other federal assistance (amount, type, aim, claim conditions); status of claims; number of jobs at time of announcement (managerial, supervisory and production positions, and/or operating staff); and number of jobs as of December 31, 1995 (managerial, supervisory and production positions, and/or operating positions, and/or operating staff).

Mr. Sherwood gave Notice of Motion 5 that on Thursday, February 22, 1996 he would move the following resolution, seconded by Mr. Robichaud:

WHEREAS the neurosurgery unit at the Saint John Regional Hospital serves residents of the western corridor of the province and the neurosurgery unit at the Moncton Hospital serves residents of the eastern corridor of the province; and

WHEREAS increased separation from families and in urgent cases increased travel time are not in the best interests of the patient,

BE IT RESOLVED that this Government consider maintaining both neurosurgical units in Moncton and Saint John.

Mr. Volpé gave Notice of Motion 6 that on Thursday, February 29, 1996 he would move the following resolution, seconded by Mr. D. Graham:

WHEREAS the *Schools Act* empowers the Minister of Education, without the consent of the Legislative Assembly, to divide the province into school districts;

WHEREAS the Legislative Assembly believes that local school boards must have a more direct role in developing school standards, assessing school performance, and creating real partnerships between schools, communities, and all stakeholders that make up our knowledge acquisition framework;

BE IT THEREFORE RESOLVED that the Legislative Assembly direct the Minister of Education to refrain from exercising his power under section 13 of the *Schools Act* until he has reported to this Assembly how he intends to increase the powers of the school boards to enable them to play a stronger, more direct role in developing school standards and assessing school and student performance, to be accountable for that performance, and to operate partnerships between schools, communities, and all stakeholders that constitute our knowledge acquisition framework.

Mr. D. Graham gave Notice of Motion 7 that on Tuesday, February 13, 1996 he would move the following resolution, seconded by Mr. Robichaud:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House for each of the fiscal years 1991-92, 1992-93, 1993-94 and 1994-95 and for the period April 1, 1995 to December 31, 1995, the following detailed breakdown of the travel expenses paid by the Province of New Brunswick related to international travel: department; date of trip; length of trip; purpose of trip; name of traveller; position; transportation cost (including cost of airline ticket); other costs (lodging, meals, entertainment, other); total cost; and a copy of any press release, communique or newspaper article related to the trip.

Mr. Mockler gave Notice of Motion 8 that on Tuesday, February 13, 1996 he would move the following resolution, seconded by Mr. D. Graham:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House for each of the fiscal years 1991-92, 1992-93, 1993-94 and 1994-95 and for the period April 1, 1995 to December 31, 1995, the following detailed breakdown of travel expenses incurred for each trip made on official NB Government business by the Premier, any staff member of the Premier's Office and any departmental official accompanying the Premier: name of trip; date of trip; purpose of trip; length of trip; number of participants on the trip (include name of all participants, if external participant, include name of the company being represented); mode of travel; transportation cost (include cost of commercial and leased aircraft transportation); other costs (lodging, meals, entertainment, other); total cost; amount charged to Premiers Office; amount recovered from and/or charged to other NB Government departments, agencies or Crown corporation; amount recovered from any Government of Canada department, agency or Crown corporation; amount recovered from any person, company, association or other private sector participant; and a copy of any press release, communique or newspaper article related to the trip.
