Pursuant to Standing Rule 99, the Clerk of the House convened a meeting of the Standing Committee on Crown Corporations on Thursday, February 8, 1996, in the Legislative Council Chamber and presided over the election of a Chairman and a Vice-chairman.

On motion, Mr. McKay was elected Chair of the Committee, and Mr. Kavanaugh was, on motion, elected Vice-chair. And your Committee begs leave to make a further report. (Sgd.) John McKay, M.L.A. Chairman. Ordered that the Report be received, that leave be granted, and the Committee continued. During Oral Questions, Mr. Speaker reminded Members to direct their remarks through the chair. Introduction of Bills The following Bills were introduced and read the first time: By Hon. Mrs. Breault, Bill 21, An Act to Amend the Assessment Act. Bill 22, An Act to Amend the Libraries Act. Ordered that the said Bills be read the second time at the next sitting. **Notices of Motions** Mr. D. Graham gave Notice of Motion 23 that on Thursday, February 29, 1996 he would move the following resolution, seconded by Mr. Mockler: That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House copies of all memoranda, correspondence, studies, reports, and other pertinent documents dealing with the monitoring of the effect on consumers and on manufacturers of the two-cent-a-litre gasoline tax reduction announced in 1992. Documentation to include all items prepared by and for the Premier's Office and the Departments of Finance, Natural Resources and Energy, Economic Development and Tourism. Documents to include all communications from and sent to industry. Mr. Volpé gave Notice of Motion 24 that on Thursday, February 29, 1996 he would move the following resolution, seconded by Mr. Sherwood: That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House for each of the 1993-94 and 1994-95 fiscal years, and up to today, the following information on each grant, contribution, loan, forgivable loan, and tax exemption provided by the Department of Economic Development and Tourism under the strategic assistance program:

company name; company location; urban or rural designation; amount of assistance received from the province (direct or indirect); specific conditions for assistance; total company investment; product or service provided.

Mr. Robichaud gave Notice of Motion 25 that on Thursday, February 29, 1996 he would move the following resolution, seconded by Mr. D. Graham:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House for each of the years 1991-92, 1992-93, 1993-94 and 1994-95 to the present, copies of all correspondence, memorandums, reports, documents written by the Premier, Premier's Staff, Ministers, Ministers' Staff, Deputy Minister and other government officials dealing with the Canada Health and Social Transfer Agreement.

Mr. Robichaud gave Notice of Motion 26 that on Thursday, February 29, 1996 he would move the following resolution, seconded by Mr. Volpé:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House a list showing the following information: the number of information/communication officers, by classification and titles, serving the government of New Brunswick (departments, Crown agencies and corporations) as of December 31, 1995 (including management and supervisory positions).

For each information/communication officer: department; classification; salary (annual); number of years of experience working as an information/communication officer for the government of New Brunswick; name of employer prior to employment by the government, and occupation; formal experience (nature and level attained); training courses attended over the past five years (provider, location, duration, subject, cost); main duties and responsibilities (including information as a percentage); number of press releases prepared and published for each of the 1991-92, 1992-93, 1993-94, and 1994-95 fiscal years, and for the period between April 1, 1995, and December 31, 1995.

Also provide the number of information/communication officers employed by the government of New Brunswick (departments, Crown agencies and corporations) as of October 1, 1987 (including supervisory and management positions).

Mr. Sherwood gave Notice of Motion 27 that on Thursday, February 29, 1996 he would move the following resolution, seconded by Mr. Robichaud:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House copies of all memos, correspondence, studies, reports, Requests for Proposals, proposals, contracts, financial arrangements and other pertinent documents dealing with the use or proposed use of the services of Andersen Consulting by all government departments and crown agencies.

Correspondence to include all communications received from and sent to industry, industry associations and Government of Canada.
