Mr. Speaker informed the House that by tradition the day is reserved for the closing of the Throne Speech debate and that no other business is transacted other than second and third reading of Bills.

Government Motions re Business of House

Hon. Mr. Frenette apprised the House that it was the intention of the Government to proceed with the closing of the Throne Speech Debate, followed by second and third reading of Bills.

A Point of Order was raised by Mr. Robichaud, his Point of Order being that the Government House Leader had not indicated the government's intention on proceeding with Bill 23.

In responding to the Point of Order, Hon. Mr. Frenette advised that he would inform the House accordingly when the order for second reading was called.

On a Point of Order, Mr. Robichaud referred to Standing Rule 44(1) which states that on Tuesdays and Thursdays the first Order of the Day shall be Private Members' Public Business.

Mr. Speaker stated that by tradition the day is reserved for closing the Throne Speech debate and the only other business transacted is that which is most necessary. Mr. Speaker stated that traditionally motions are not debated and they will not be today.

Government Motions re Business of House

At the request of Hon. Mr. McKenna, Mr. Speaker reverted to the Order of Government Motions for the Ordering of the Business of the House.

On motion of Hon. Mr. McKenna, seconded by Hon. Mr. Blanchard,

RESOLVED that the Address in Reply to the Speech from the Throne be engrossed, signed by Mr. Speaker, and presented to Her Honour by a Committee of the House.

Ordered that Mr. Flynn, Mr. A. Landry and the Hon. Mr. McKenna be the Committee to wait upon Her Honour with the Address and present the same.

At the request of Hon. Mr. Frenette, Mr. Speaker reverted to the Order of Government Motions for the Ordering of the Business of the House.

Hon. Mr. Frenette announced that third reading of Bills would be stood until tomorrow and that second reading would proceed forthwith.

Leave was granted to stand all Bills scheduled for third reading on this day's Order and Notice Paper until Friday, December 6, 1996.

Second Reading

The following Bills were read the second time and ordered referred to the Committee of the Whole House:

Bill 19, Statute Law Amendment Act 1996.

Bill 20, An Act to Repeal the Pension Fund Societies Act.

Bill 21, An Act to Amend the Loan and Trust Companies Act.

Bill 22, An Act Respecting Health Professionals.

And the Order being read for second reading of Bill 23, *An Act to Amend the Municipal Assistance Act*, Hon. Mr. Valcourt arose on a Point of Order to request that Mr. Speaker direct the withdrawal of Bill 23, *An Act to Amend the Municipal Assistance Act*, because the Bill was not first recommended to the House by message of Her Honour the Lieutenant-Governor in the session in which it was proposed. In stating his Point of Order, the Honourable Leader of the Opposition referred to Standing Rule 107 and *Beauchesne's Parliamentary Rules and Forms Fifth Edition*, paragraphs 539 and 540 at page 181.

The Honourable Leader suggested that Bill 23 proposes to appropriate part of the public revenue to municipalities in New Brunswick and thus required a Recommendation by the Crown before it can be considered. He suggested that to consider the Bill without the appropriate message from Her Honour the Lieutenant-Governor would be a fundamental breach of Parliamentary rules and a violation of Standing Rule 107.

After hearing the comments of other Members on the Point of Order, Mr. Speaker took the matter under advisement.

Accordingly, leave was granted to defer Second Reading of Bill 23, *An Act to Amend the Municipal Assistance Act,* pending the decision of the Speaker.

And then, 11.38 o'clock a.m., the House adjourned.
