

Prayers.
Petitions
Mr. MacLeod, Member for Moncton Crescent, laid upon the table of the House a petition signed by residents of the Greater Moncton Area regarding their opposition to the opening of the Petitcodiac River flood gates and possible changes to the water control in the Petitcodiac River. (Petition 10)
During Oral Questions, Mr. Speaker advised that certain remarks made by the Leader of the Opposition were unparliamentary and requested that Hon. Mr. Valcourt withdraw them, which he did.
Hon. Mr. Frenette rose on a Point of Order, referring to comments made by Hon. Mr. Valcourt which may have reflected on the Speaker and requested that Hon. Mr. Valcourt apologize to the Chair.
Mr. Speaker indicated a comment was made which reflected on the Chair. Mr. Speaker further indicated that he had requested a withdrawal but did not have further power to order an apology.
Hon. Mr. Frenette rose on a Point of Order, his point of order being that comments made by Hon. Mr. Valcourt that the New Brunswick Legislative Assembly was "a joke" is unparliamentary and must be withdrawn.
Mr. Speaker advised that he did not hear the remark but would undertake to review the Hansard transcripts.

Ordered referred to the Standing Committee on Private Bills.

Government Motions re Business of House

Hon. Mr. Frenette announced that it was the intention of the government to adjourn the House subject to the recall of the Speaker and that, tentatively, the House would be recalled on Thursday, January 30, 1997.

It was moved by Hon. Mr. Frenette, seconded by Hon. Mr. Tyler,

THAT when this Assembly adjourns at the end of this sitting day, it shall stand adjourned to a date and time to be set by Mr. Speaker upon the request of the Government, whereupon Mr. Speaker shall give the Members reasonable notice of such date and time, and that in the event of Mr. Speaker being unable to act owing to illness or other cause, either of the Deputy Speakers shall act in his stead for the purpose of this order.
