

Bill 9 fails to protect the privacy of New Brunswick workers by granting to the minister of Advanced Education and Labour discretionary powers that are too broad in scope.

Mr. Speaker put the question on the amendment, and it was negatived.

Debate continued on the motion for second reading.

And the debate being ended, Mr. Speaker put the question on the motion that Bill 9 be now read a second time, and the motion was carried.

Accordingly, Bill 9, *An Act to Amend the Labour Market Research Act*, was read a second time and ordered referred to the Committee of the Whole House.

The Order being read for second reading of Bill 11, *An Act Respecting Gasoline and Diesel Oil Fair Marketing Practices*, a debate arose thereon.

And after some time, Mr. Speaker interrupted proceedings and declared it to be 12.30 o'clock p.m. and left the chair, to resume again at 2 o'clock p.m.

The Order being read for second reading of Bill 12, *An Act to Amend the Prescription Drug Payment Act*, a debate arose thereon.


