

## **Government Motions re Business of House**

Hon. Mr. Tyler announced that it was the intention of the government to resume the budget debate followed by resumption of debate on the motion for second reading of Bill 7. The House would then proceed to the Committee of the Whole to consider legislation.

With leave of the House, Hon. Mr. Tyler moved the following resolution, seconded by Mr. Allaby:

That the membership of the Standing Committee on Private Bills be amended by substituting the name of Mr. Mesheau for Mr. Sherwood:

That the membership of the Standing Committee on Law Amendments be amended by substituting the names of Mr. J. Doyle for Mr. Allaby, and Mr. Mesheau for Mr. Robichaud; and

That the membership of the Standing Committee on Public Accounts be amended by adding the name of Mr. J. Doyle, and by substituting the name of Mr. Mesheau for Hon. Mr. Valcourt.

And the question being put, it was resolved in the affirmative.

# **Second Reading**

Debate resumed on the motion that Bill 7, An Act to Amend the New Brunswick Highway Corporation Act, be now read a second time.

And after some time, Hon. Mr. Tyler rose on a Point of Order, his point of order being that the Member for Madawaska-la-Vallée was not speaking on the principle of the Bill.

Mr. Speaker ruled that although debate on the principle of the Bill at second reading is considerably far reaching, it does not allow for an in-depth discussion on a clause-by-clause basis, which is reserved for Committee of the Whole. Mr. Speaker stated that he would continue to monitor the debate.

And after some time, Mr. Mockler moved in amendment, seconded by Mr. D. Graham:

#### **AMENDMENT**

THAT the motion for second reading be amended by deleting all the words after the word "that" and substituting the following:

Bill No. 7, An Act to Amend the New Brunswick Highway Corporation Act, be not now read a second time but that it be read a second time this day six months hence.

And the question being put, a debate ensued.

And after some time, Hon. Mr. Tyler rose on a Point of Order, his point of order being that the debate at second reading should not deal with the different sections of the Bill as the Minister does not have the opportunity to respond accordingly.

Mr. Speaker ruled that all members have an equal opportunity to speak and an equal opportunity to be heard and that no member is restricted from participating in debate.

And after some time, Mr. Speaker reminded members that they were not now debating the principle of the Bill before the House but were dealing with a very specific amendment to the motion for second reading.

And after some further time, Mr. Speaker requested that members refrain from standing and holding conversations within the Chamber while another member has the floor.

At 12.30 o'clock p.m., Mr. Speaker left the chair to return again at 2 o'clock p.m.
