Prayers

Hon. Mr. C. Thériault paid tribute to a former Fredericton city councillor, Donald Kelly, now deceased. Mr. Green joined with Hon. Mr. Thériault in this regard.

Bill 2, An Act to Amend the Family Services Act.

Ordered that the said Bill be read the second time at the next sitting.

WHEREAS the Legislative Assembly has adopted the *Balanced Budget Act*, assented to May 7, 1998; and

THEREFORE BE IT RESOLVED that the Legislative Assembly urge the government for the sake of honesty to the taxpayers of New Brunswick, and in accordance with its responsibility, to correct its financial statements and reflect the operating deficit of \$267.3 million for the year ended March 31, 1998 which is in breach of the *Balanced Budget Act*.

Mr. Green gave Notice of Motion 57 that on Tuesday, December 8, 1998 he would move the following resolution, seconded by Mr. Mesheau:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House a copy of all memos, documents, correspondence and electronic mail in the last five (5) years between nurses and nursing organizations and the Minister of Health and Community Services regarding nursing shortages.

Mr. Green gave Notice of Motion 58 that on Tuesday, December 8, 1998 he would move the following resolution, seconded by Mr. Mesheau:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House a copy of all memos, documents, correspondence and electronic mail in the last five (5) years between physicians, physician organizations, nurses, nursing organizations, related healthcare workers, Emergency Medical Officers, concerned citizens, and interest groups and the Minister of Health and Community Services related to ambulance service.

Government Motions re Business of House

Hon. Mr. Byrne announced that following Private Members' Motions it was the intention of the government that the House resume debate on the motion for an Address in Reply to the Speech from the Throne.

Private Members' Motions

Pursuant to Notice of Motion 1, Mr. Lord, seconded by Mr. Robichaud, moved:

WHEREAS we are committed to the five principles of the *Canada Health Act*: publicly administered, universal, portable, accessible, and compre-hensive; and

WHEREAS we want a health care system that puts the patient first, a system that will ensure meaningful involvement for providers, consumers, and communities in shaping the future direction of heath care; and

WHEREAS healthcare funding must be based on a combination of quality of service as well as financial accountability; and

WHEREAS there is a need to reevaluate the current services that are delivered; therefore

BE IT RESOLVED that this Legislature urge the government to introduce legislation that would guarantee provision of appropriate levels of healthcare services to all New Brunswickers regardless of where they live in New Brunswick.

And the question being put, a debate ensued.

And after some time, Hon. Mr. MacDonald, seconded by Hon. Mrs. Breault moved in amendment:

AMENDMENT

- 1. In the fourth paragraph, by deleting the word "a" and inserting the words "an ongoing", by deleting the word "reevaluate", and inserting the word "evaluate" and by deleting the words "the current" and inserting the word "healthcare" and also by deleting the words "that are delivered";
- 2. In the resolution clause, by deleting the words "to introduce legislation that would guarantee provision of" and replacing them with the words "to continue providing", by deleting the words "levels of", by deleting the word "to" and replacing it with the word "for" and by deleting the word "New Brunswick" and replacing it with the words "the province".

Mr. Speaker having put the question on the amendment, Mr. Robichaud rose on a Point of Order, his point of order being that a member who has spoken when moving an amendment is precluded from speaking again.

After hearing from several members on the point of order, Mr. Speaker ruled that the practice in this House is to permit a member to move an amendment and then speak on the amendment provided the member has not prefaced the moving of the amendment with any other remarks.

And a debate ensuing on the amendment,

After some time, Ms. de Ste. Croix, Deputy Speaker, took the Chair as Acting Speaker.

After some further time, Mr. Lord rose on a Point of Order, to clarify certain remarks that had been attributed to him by Mr. MacLeod during the course of debate.

Madam Deputy Speaker ruled that Mr. Lord's point of order was not well taken.

Mr. Robichaud rose on a Point of Order, his point of order being that the practice of this House is that Members may rise on a point of order to correct false or inaccurate remarks made by another Member.

Mr. Speaker resumed the Chair.

After hearing from other Members on the point of order, Mr. Speaker ruled that the matter concerned a difference of opinion between two Members and the point of order was not well taken.

And the debate continuing,

And after some time, Mr. Speaker interrupted proceedings and announced that the time for Private Members' Motions had expired.
