Prayers.

Hon. Mr. Green announced that it was the government's intention that the House resolve itself into a Committee of Supply to consider the estimates of the Department of Training and Employment Development, followed by the estimates of the Department of Health.

After requesting Mr. Speaker revert to the order of Notices of Motions, Mr. S. Graham gave Notice of Motion 150 that on Tuesday, May 30, 2000, he would move the following resolution, seconded by Mr. C. Thériault:

That an address be presented to Her Honour the Lieutenant-Governor, praying that she cause to be laid upon the table of the House, since the budget was released March 28, 2000, the numbers of hours and the cost incurred by the Premier using a government leased plane and/or other private aircraft.

The House, according to order, resolved itself into a Committee of Supply with Mr. Ashfield in the chair.

And after some time, the Chairman declared it to be 12.30 o'clock p.m., and left the chair to resume again at 2 o'clock p.m.

2 o'clock p.m.

The Committee resumed.

And after some time, Ms. Weir rose on a Point of Order and requested that the Chairman rule on the requirement of the Minister to respond to the Member's questions on the Workplace Health, Safety and Compensation Commission.

The Chairman ruled that the duty of the chair is to decide questions of order and procedure and not whether responses by Ministers are to the satisfaction of Members.

At 4.45 o'clock p.m., the Chairman declared a brief recess.

4.57 o'clock p.m.

The Committee resumed.

And after some time, Mr. Speaker resumed the chair, and Mr. Ashfield, the Chairman, after requesting that Mr. Speaker revert to Presentations of Committee Reports, reported that the Committee had made some progress in the consideration of the matters referred to them, had passed several items and asked leave to sit again.

Pursuant to Standing Rule 78.1, Mr. Speaker put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.
