Ms. Weir gave Notice of Motion 91 that on Thursday, June 13, 2002, she would move the following resolution, seconded by Mr. Kennedy:

That an address be presented to Her Honour the Lieutenant-Governor praying that she cause to be laid upon the table of the House by the Minister of Health and Wellness, copies of any and all documents, correspondence, memos, reports, between the Minister of Health and Wellness, or any official in his Department, and Health Canada related to the e-coli outbreak in Saint John.

Ms. Weir gave Notice of Motion 92 that on Thursday, June 13, 2002, she would move the following resolution, seconded by Mr. Kennedy: That an address be presented to Her Honour the Lieutenant-

That an address be presented to Her Honour the Lieutenant-Governor praying that she cause to be laid upon the table of the House by the Minister of Natural Resources and Energy copies of the following two documents:

- 1. List of Deviations and the Disposition of these Deviations provided in a table as part of the Completion of the Codes and Standards Review by NB Power for the Point Lepreau Nuclear Power Plant filed with the Canadian Nuclear Safety Commission's Point Lepreau Compliance and Licensing Division as an attachment to a May 28, 2002, letter from Mr. Paul Thompson, Licensing Manager for Point Lepreau.
- 2. NB Power Point Lepreau Refurbishment Risk Assessment Report produced for NB Power by Ernst & Young, December 2001.

Bill 68, An Act to Amend the Legislative Assembly Act.

With the unanimous consent of the House, it was agreed that Bill 68 be ordered referred to the Committee of the Whole House for consideration during the current day's sitting, following consideration of Bill 64.

The House resolved itself into a Committee of the Whole with Mr. Bernard in the chair.
