Ms. Weir, Member for Saint John Harbour, laid upon the table of the House a petition on behalf of citizens of New Brunswick who request that the House set up a commission to examine future rate increases by insurance companies. (Petition 1)

Mr. Richard stood on a point of order to complain that the written copy of a statement made by the Minister of Transportation was received in one language only.

The Honourable the Premier spoke on the point of order and noted that the statement was made and distributed in both official languages.

Mr. Speaker advised that in keeping with the practices of the House, copies of written documentation such as Statements by Ministers should be distributed in both official languages at the same time.

Mr. Speaker introduced the pages for the session: Returning from last session are Nicholas Ouellette, Hatfield Point; who will serve as Head Page; Jarrette Bannister, Elgin; Andy MacNeil, Durham Bridge and Janice Linton, of Perth-Andover.

WHEREAS debt load for graduates of medical schools is extremely high;

AND WHEREAS other provinces and the United States are offering significant debt reduction incentives to new physicians;

AND WHEREAS there are communities where there are severe shortages of physicians;

AND WHEREAS there is a known shortage of health care providers including nurses, nurse practitioners and others;

AND WHEREAS New Brunswick's best chance at dealing with this shortage comes from training New Brunswickers in these professions;

AND WHEREAS the cost of these programs may be prohibitive for young people wanting to pursue careers in health care provision;

BE IT THEREFORE RESOLVED THAT this Legislature urge the government to establish a New Brunswick Healthcare Bursary Program to students entering their last 2 years of study in one of the health care professions identified as experiencing a shortage who agree to work in the province after graduation;

BE IT FURTHER RESOLVED THAT this Legislature urge government to establish a Debt Assistance Plan for new physicians to establish a medical practice in a designated community. Mr. Shawn Graham gave Notice of Motion 2 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Richard:

WHEREAS an Act introducing nurse practitioners was adopted during the last session of the Legislative Assembly;

WHEREAS the University of New Brunswick only offers a part-time nurse practitioner program;

WHEREAS there is no Francophone nurse practitioner program at the Université de Moncton;

WHEREAS nurse practitioners are in very high demand across the country;

BE IT THEREFORE RESOLVED that the Legislative Assembly urge the New Brunswick government to set up a dedicated fund for a nurse practitioner program at the Université de Moncton and at the University of New Brunswick.

Mr. Shawn Graham gave Notice of Motion 3 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Kennedy:

WHEREAS enrolment is dropping in the New Brunswick school system;

AND WHEREAS dropping enrolment affords us the opportunity to improve the ratios of teaching staff to students and to provide more resouces to children with learning disabilities;

AND WHEREAS improved ratios have a beneficial effect on academic performance;

AND WHEREAS the government is currently cutting teaching positions;

BE IT RESOLVED that this Legislature urge the government to implement a freeze on the number of teaching positions in the education system for three years.

Mr. Shawn Graham gave Notice of Motion 4 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Allaby:

WHEREAS all New Brunswickers are shareholders in NB Power;

AND WHEREAS public consultation conducted by the Official Opposition indicated overwhelmingly that New Brunswickers favour retaining control of NB Power as a publicly-owned utility; AND WHEREAS deregulation in Ontario has led to rate shock which has led the Ontario government to introduce legislation capping the price of wholesale electricity;

BE IT THEREFORE RESOLVED that this Legislature urge the government to adopt the policy of retaining control and ownership of generation and transmission infrastructure of NB Power.

Mr. Shawn Graham gave Notice of Motion 5 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Haché:

WHEREAS northeastern New Brunswick has an economic development deficit compared to the rest of the province;

WHEREAS the unemployment rate, especially the seasonal unemployment rate, is very high in the northeastern part of the province;

WHEREAS the northeastern part of the province is experiencing an exodus of young people from the area, who leave to attend university or to pursue better job opportunities;

WHEREAS the Nova Scotia government has been very proactive in setting up, with federal government assistance, the Enterprise Cape Breton Corporation and the Pictou Regional Development Commission;

WHEREAS both these economic development programs have proved their worth, and several jobs have been created thanks to the commitment of the Nova Scotia government, which has innovated on these issues;

BE IT THEREFORE RESOLVED that the Legislative Assembly urge the New Brunswick government to cooperate with the federal government with a view to setting up an inclusive economic development program for the northeastern part of the province, similar to the Enterprise Cape Breton Commission.

Mr. Shawn Graham gave Notice of Motion 6 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Richard:

WHEREAS auto insurance rates are escalating at an alarming rate;

AND WHEREAS seniors, who are often on fixed incomes, are being hurt by large increases in premiums;

AND WHEREAS other provinces have been able to bring stability to auto insurance rates;

AND WHEREAS the Select Committee on Private Passenger Automobile Insurance has been provided with much information on the problem;

BE IT RESOLVED that the Legislature urge the government to take immediate steps to deal with the escalating costs of auto insurance.

Mr. Shawn Graham gave Notice of Motion 7 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Richard:

WHEREAS one in 500 children is affected by autism;

AND WHEREAS in the case of *Auton v. British Columbia*, the BC Court of Appeal ruled that British Columbia's failure to provide effective treatment for a child with autism was a violation of that child's rights under the *Canadian Charter of Rights and Freedoms*;

AND WHEREAS the Government of New Brunswick is in possession of the report *A Framework for an Integrated Service Delivery System for Persons with Autism in New Brunswick* from the Interdepartmental Committee on Services to Persons with Autism;

BE IT THEREFORE RESOLVED that this Legislature urge the government to implement the recommendations of A Framework for an Integrated Service Delivery System for Persons with Autism in New Brunswick.

Mr. Shawn Graham gave Notice of Motion 8 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Allaby:

WHEREAS the ceiling levels for transfers for coverage of the cost of prescription drugs from the provincial Prescription Drug Program for seniors to the Blue Cross plan for seniors were established in 1992 to be \$17 198 for a single senior and \$26 955 for married seniors and have remained at that level;

AND WHEREAS inflation over the years reduces the purchasing power of seniors' earnings;

AND WHEREAS the government has recognized this in its provincial income tax legislation with a provision to prevent "bracket creep";

BE IT THEREFORE RESOLVED that the Legislative Assembly ask the government to examine the feasibility of making an adjustment to this ceiling in the coming year to reflect the above index of inflation in the intervening years;

BE IT FURTHER RESOLVED that the Legislative Assembly ask the government to consider adopting a policy that would automatically adjust the ceilings for the provincial Prescription Drug Program based on an appropriate index of inflation to prevent bracket creep from imposing hardship on seniors.

Mr. Shawn Graham gave Notice of Motion 9 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mrs. Mersereau:

WHEREAS on June 1, 2000 the Minister of Family & Community Services stated, "the long-term care review is currently under way and is scheduled to be completed by the fall;"

AND WHEREAS more than two years have passed without the release of a long-term care strategy;

AND WHEREAS there are many concerns about the availability, sustainability and quality of long-term care in the province of New Brunswick;

BE IT THEREFORE RESOLVED that this Legislature urge the government to bring forward and implement a Long-Term Care strategy for New Brunswickers requiring long-term care in our province.

Mr. Shawn Graham gave Notice of Motion 10 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mrs. Mersereau:

WHEREAS women's average hourly wage is 79 % of men's in New Brunswick;

WHEREAS the Advisory Council on the Status of Women states that approximately half the wage gap is "caused by the age-old tradition of paying 'women's' jobs less than jobs usually held by men";

WHEREAS the New Brunswick government must show leadership in the area of pay equity;

WHEREAS there are still parts of the public service which are not covered by the *Pay Equity Act* and which include New Brunswick government employees;

BE IT THEREFORE RESOLVED that the Legislative Assembly urge the New Brunswick government to amend the *Pay Equity Act* so that it applies to all parts of the public service;

AND BE IT FURTHER RESOLVED that the Legislative Assembly urge the New Brunswick government to actively pursue an objective of ensuring that the *Pay Equity Act* applies to the private sector.

Mr. Shawn Graham gave Notice of Motion 11 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Haché:

WHEREAS New Brunswick universities will receive nearly \$168 million in funding from the provincial government in 2001-02;

WHEREAS there is no mechanism requiring the universities to be accountable to the Legislative Assembly for how this money is spent;

WHEREAS the Select Committee on Education was formed at the commencement of the First Session of the 54th Legislative Assembly to address the many issues and concerns involving the education of New Brunswickers;

BE IT THEREFORE RESOLVED that this Legislative Assembly authorize the Select Committee on Education to invite representatives of the province's universities to appear before the committee to review their spending and outline their plans and priorities.

Mr. Shawn Graham gave Notice of Motion 12 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mrs. Mersereau:

WHEREAS the "Children Come First" report was released in June 2000;

AND WHEREAS the report contained 84 recommendations;

AND WHEREAS the "Children Come First" report recommended that 177 new social workers be hired into Child Protection, Child in Care, Children's Residential Services and Adoption Services;

AND WHEREAS that hiring has not occurred;

AND WHEREAS workload was a key issue during the recent strike by social workers;

BE IT THEREFORE RESOLVED that the Legislative Assembly urge the government to act on implementing recommendations regarding social workers in the "Children Come First" report. Mr. Shawn Graham gave Notice of Motion 13 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mrs. Mersereau:

WHEREAS the report "Children Come First" was released in June 2000;

AND WHEREAS that report recommended the establishment of a Child / Youth Advocate as a "champion to give a voice to children.";

AND WHEREAS the report recommended the position be an "impartial body to support the vision for child well-being in New Brunswick and would report directly to the Legislature, and in the case of the First Nations, to the Tripartite Committee";

BE IT THEREFORE RESOLVED that this Legislature urge the government to establish a Child / Youth Advocate.

Mr. Shawn Graham gave Notice of Motion 14 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mrs. Mersereau:

WHEREAS the report "Children Come First" was released in June 2000;

AND WHEREAS that report raised concerns about services for youth 16-18 who are falling through holes in the social safety net;

AND WHEREAS the New Brunswick Foster Families Association is currently circulating a petition in favour of better, more consistent services to youth 16-18;

AND WHEREAS no action has been taken to this point on these recommendations;

BE IT THEREFORE RESOLVED that this Legislature urge the government to review provision of services to youth age 16 - 18 to ensure that they receive the services and support they require.

Mr. Shawn Graham gave Notice of Motion 15 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Allaby:

WHEREAS coastal communities are vitally dependent on sustainable and renewable resources of the sea for their prosperity;

AND WHEREAS coastal economies are now more diversified with aquaculture and tourism added to activities in commercial fishing;

Agriculture, Fisheries & Aquaculture confirmed that the provincial government has no policy for the commercial fisheries;

BE IT THEREFORE RESOLVED that the Legislature urge the government to consult with stakeholder representatives of coastal communities in all regions of New Brunswick and develop a "Coastal Resource Policy" to assist government in decisions affecting the various sectors of the coastal economy to assure harmony among the sectors and sustainable and prosperous coastal communities.

Mr. Shawn Graham gave Notice of Motion 16 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mrs. Mersereau:

WHEREAS a key aim of the Advisory Council on the Status of Women is to "increase awareness of the population on issues, programs and services;"

AND WHEREAS the Advisory Council on the Status of Women has launched a campaign to raise awareness of the issue of the need for pay equity;

AND WHEREAS one of the targets for this campaign is young New Brunswickers and in particularly girls;

AND WHEREAS one piece of campaign material will not be placed in New Brunswick classrooms because the Department of Education is concerned that it is not presented in the context it requires;

BE IT RESOLVED that this Legislature urge the Department of Education and the Advisory Council on the Status of Women take a cooperative approach in implementing this important awareness campaign in our schools.

Mr. Shawn Graham gave Notice of Motion 17 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Lee:

WHEREAS the province of New Brunswick has a Days of Rest Act;

AND WHEREAS the Days of Rest Act states "it is desirable to provide, as much as is practicable, that such days of rest be uniform;"

AND WHEREAS exemptions to the Days of Rest Act are now being given frequently and inconsistently;

AND WHEREAS municipalities, business and individuals have called upon government to outline a consistent Sunday shopping policy;

BE IT THEREFORE RESOLVED that this Legislature urge the government to refer the *Days of Rest Act* to the Standing Committee on Law Amendments to obtain public input on possible amendments to the Act.

Mr. Shawn Graham gave Notice of Motion 18 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Allaby:

WHEREAS it has been acknowledged by government that good transportation infrastructure is essential for economic growth;

AND WHEREAS growth of the Grand Manan economy is being constrained by lack of opportunity to increase capacity of the ferry service due to the 37-year old terminal in Blacks Harbour that will not permit ferries of sufficient size to be docked there;

AND WHEREAS economic activity on Grand Manan has positive benefits for much of southern New Brunswick;

AND WHEREAS while the North Head terminal was being replaced in the spring of 1999, plans were being made to start the process for replacement of the Blacks Harbour Wharf, plans that were cancelled when the present government took office;

AND WHEREAS the Minister of Transportation noted in his Estimates this year his hope to see money in the capital budget this fall to build the Blacks Harbour terminal;

BE IT RESOLVED that the Legislature ask the government to attach a very high priority to building the Blacks Harbour wharf in time to have it in service before the 2004 biennial refit of the ferry *Grand Manan V*.

Mr. Shawn Graham gave Notice of Motion 19 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. Allaby:

Mr. MacKenzie gave Notice of Motion 21 that on Tuesday, November 26, 2002, he would move the following resolution, seconded by Mr. LeBlanc:

WHEREAS testing of New Brunswick student in both the Francophone and Anglophone systems over many years has consistently shown evidence that there is room for improvement; and

WHEREAS this Government has taken measures to improve the quality of learning available to children participating in both the Anglophone and Francophone K-12 education systems; and

WHEREAS every New Brunswick student deserves the opportunity to take part in and benefit from the highest possible quality learning environment;

BE IT THEREFORE RESOLVED that the Government of New Brunswick continue to develop and implement programming, curriculum, and governance options which will have a positive impact on the quality of learning opportunities available to New Brunswick students.

WHEREAS the training, recruitment, and retention of physicians, particularly family doctors and specialists, have become an issue of great concern across North America;
