Accordingly, Bill 36, *An Act to Amend the All-Terrain Vehicle Act*, was read a second time and referred to the Committee of the Whole House.

Bill 37, An Act to Amend the Members' Conflict of Interest Act. Bill 39, An Act to Amend the Small Claims Act.
