Pursuant to Standing Rule 10, Hon. Mr. Murphy, Minister of Health, rose on a point of privilege to correct statements contained in an article published in the May 18 edition of the *Moncton Times-Transcript*.

Hon. Mr. Byrne, Minister of Business New Brunswick, welcomed to the House Ambassador Shin, the permanent representative to the ICAO and the Consul General of the Republic of Korea and Mr. Min, Consul of the Korean Mission in Montreal. Mr. MacDonald joined with the Minister in this regard.

Hon. Mr. Ouellette, Minister of Agriculture and Aquaculture, welcomed to the House Mr. Yvon Poitras, a former Progressive Conservative MLA for Restigouche-West (1982-1987). Mr. Mockler joined with the Minister in this regard.

Mr. Williams, Member for Kent South, laid upon the table of the House a petition signed by citizens of the Cocagne area requesting that the government continue school renovations at the Clément-Cormier school during the summer of 2007. (Petition 37)

Hon. Mr. Jamieson, Government House Leader, announced that it was the intention of government that the House resolve itself into a Committee of Supply to consider of the estimates of the Department of Health.

The House, according to Order, resolved itself into a Committee of Supply with Mr. R. Boudreau in the chair.

And then, 4 o'clock p.m., the House adjourned.
