It was agreed by unanimous consent to extend the time allotted for Oral Questions by 30 minutes.

With leave of the House to dispense with notice, Hon. Mr. Murphy moved the following resolution, seconded by Hon. Mr. Lamrock: (Motion 33)

THAT the membership of the Standing Committee on Crown Corporations be amended by substituting the name Mr. Fraser for Mr. R. Boudreau.

And the question being put, it was resolved in the affirmative.
