Mr. C. LeBlanc, Member for Dieppe Centre-Lewisville, laid upon the table of the House a petition signed by members of the New Brunswick Health Coalition and the committee for equality in health services, calling on the government to respect democratic principles. [Mr. Speaker ruled the petition out of order on April 22, 2008.]

Hon. Mr. Murphy, Government House Leader, announced that it was the intention of the government that the Hosue resolve itself into a committee of Supply to take into consideration the estimates of the Department of Health, the Department of Tourism and Parks and the Department of Wellness, Culture and Sport; following which, Bills 42, 32, and 35 would be called for second reading.

The House, according to Order, resolved itself into a Committee of Supply with Mr. Kenny in the chair.

Mr. Mockler rose on a point of order and submitted that comments made by the Minister of Health on Wednesday last in relation to the "Madawaska Mafia" were unparliamentary. Mr. Chairman took the matter under advisement.

At 12.30 o'clock p.m., the Chairman left the chair to resume again at 1.30 o'clock p.m.
