Hon. Mr. Murphy welcomed to the Chamber Provincial Court Judge Hon. Michael McKee, Liberal MLA (1974-1992), and Minister of Labour (1987-1991).

Mr. Williams, Member for Kent South, laid upon the table of the House a petition on behalf of residents of Grande-Digue and surrounding areas urging the government to make changes to legislation in order to protect water, health, and property rights. (Petition 22)

Mr. Betts, Member for Moncton Crescent, laid upon the table of the House a petition on behalf of residents of the Moncton area urging the government to make changes to legislation in order to protect water, health, and property rights. (Petition 23)

Following Oral Questions, Hon. Mr. Murphy rose on a point of order and submitted that Mr. Volpé, the Leader of the Opposition, had referred to the Premier by first name, instead of by title; that Mr. Alward had questioned the Premier's honesty and integrity, and that Mr. Mockler had alleged the Premier was "lying."

Mr. Speaker ruled the point well taken in relation to referring to a Member by name; cautioned Mr. Alward when making remarks which could be regarded as questioning a Member's honesty or integrity; and advised the House that he did not hear Mr. Mockler make the remark in question. Mr. Speaker cautioned all Members against using such unparliamentary language.

Pursuant to Standing Rule 44(4), Mr. Harrison, Opposition House Leader, gave notice of the Opposition's intention to consider Opposition Members' Business in the following order on Thursday, May 22, 2008: (1) Motion 75, and (2) second reading of Bill 14.

Hon. Mr. Murphy, Government House Leader, announced that it was the intention of the government that the House resolve itself into a Committee of Supply to consider the estimates of the Department of Natural Resources.

The House, according to order, resolved itself into a Committee of Supply with Mr. Fraser in the chair.
