Mr. Williams, Member for Kent South, laid upon the table of the House a petition on behalf of residents of New Brunswick who are opposed to uranium prospecting and mining in the province. (Petition 26)

Hon. Mr. Murphy, Government House Leader, announced that it was the intention of the government that the House resolve itself into a Committee of Supply to consider the estimates of the Department of Finance, Department of Fisheries, Department of Intergovernmental Affairs, Premier's Council on the Status of Disabled Persons, Executive Council Office and Office of the Premier.

Hon Mr. Murphy further advised that on Tuesday, May 27, Bills 56, 57 and 66 would be called for second reading.

It was agreed by unanimous consent to vary the hours of sitting, to continue sitting through the noon recess, and to adjourn at 3 o'clock p.m.

The House, according to Order, resolved itself into a Committee of Supply with Mr. Fraser in the chair.

And after some further time spent in Committee of Supply, Mr. Speaker resumed the chair, and Mr. Fraser, the Chairman, after requesting that Mr. Speaker revert to Presentations of Committee Reports, reported that the Committee had had under consideration the matters referred to them, had made some progress therein, had passed several items, and asked leave to sit again.

Pursuant to Standing Rule 78.1, Mr. Speaker then put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.
