The following Bills were introduced and read a first time.

Bill 52, An Act to Amend the Municipalities Act.

By Ms. Blaney on behalf of Mr. Alward, Bill 53, *Lobbyists Registration Act.*

By Mr. Jack Carr on behalf of Mr. Alward, Bill 54, *Spending Announcement Act*.

Pursuant to Standing Rule 44(4), Mr. D. Graham, Acting Opposition House Leader, gave notice that on Thursday, April 30, 2009, it was the intention of the Opposition to consider Opposition Members' Business in the following order: second reading of Bills 54 and 53, resumption of the debate on Motion 54, and resumption of the debate on second reading of Bill 50.

Hon. Mr. Murphy, Government House Leader, announced that it was the intention of government that the House resolve itself into a Committee of the Whole to consider Bills 32, 36, 38, 31, 43, 49 and 47; following which, the House would resolve itself into a Committee of Supply to consider the estimates of the Energy Efficiency and Conservation Agency of New Brunswick, the Department of Energy, and the Department of Fisheries.

And after some time, Mr. Speaker resumed the chair and Ms. Robichaud, the Chair, after requesting that Mr. Speaker revert to Presentations of Committee Reports, reported:

Bill 47, An Act to Amend the Smoke-free Places Act.

Bill 49, An Act to Amend the Retirement Plan Beneficiaries Act.

And the Committee asked leave to make a further report.

Pursuant to Standing Rule 78.1, Mr. Speaker put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.
