Due to the unavoidable absence of Mr. Speaker, Mr. Fraser, the Deputy Speaker, took the chair as Acting Speaker.

Mr. Alward, Member for Woodstock, laid upon the table of the House a petition on behalf of citizens of the province urging the government to restore funding to the critical areas of school libraries and literacy for all children. (Petition 73)

Mr. Alward, Member for Woodstock, laid upon the table of the House a petition on behalf of citizens of the province in opposition to the reduction in funding for educational support staff. (Petition 74)

Ms. Poirier, Member for Rogersville-Kouchibouguac, laid upon the table of the House a petition on behalf of citizens of the Rogersville-Kouchibouguac region of the province urging the government to provide basic maintenance of the Sapins Courts, Young Ridge and West Collette undesignated roads. (Petition 75)

Mr. Huntjens, Member for Charlotte-Campobello, laid upon the table of the House a petition on behalf of Grade 3 students at Milltown Elementary School urging the government to provide a kidney dialysis machine for Charlotte County Hospital. (Petition 76)

Mr. Williams, Member for Kent South, laid upon the table of the House a petition on behalf of residents of the Bouctouche area urging the government to reverse its decision to cut the Bouctouche government garage to a winter only operation. (Petition 77)

Mr. Northrup, Member for Kings East, laid upon the table of the House a petition on behalf of the NB Crown Camp Lease Owners and Recreational Activities Committee in opposition to the increase in fees on Crown land leases. (Petition 78)

Pursuant to Standing Rule 44(4), Mr. Holder, Acting Opposition House Leader, gave notice that on Thursday, June 11, 2009, Opposition Members' Business would be considered in the following order: Motion 65; resumption of the second reading debate on Bills 50, 74, and 53; followed by resumption of the debate on Motion 59, and Motion 54. Hon. Mr. Murphy, Government House Leader, announced that it was the intention of government that Bills 87, 83, 58, 45, and 76 be called for second reading; following which, with leave of the House, Bills 87, 83, 58, 45, and 76 as well as Bill 27 would be considered in Committee of the

Bill 88, Personal Health Information Privacy and Access Act.

Ordered that the said Bills do pass.

The Order being read for second reading of Bill 87, *Pay Equity Act*, 2009, a debate arose thereon.

And after some time, Mr. Fraser, the Deputy Speaker called Mr. A. LeBlanc to order for disrupting proceedings.

And after some further time, Ms. Blaney stood on a point of order and submitted that the Member for Saint John Lancaster was attacking her as a female Member and was being disruptive.

The Deputy Speaker warned Mr. A. LeBlanc that he would be asked to leave the Chamber if he persisted in being disruptive.

And after some further time, Hon. Mr. Murphy rose on a point of order and submitted that Ms. Blaney was continuing the disruptive behaviour by focusing her remarks on the Member for Saint John Lancaster. Ms. Blaney spoke on the point of order and apologized to the House.

And the debate being ended, and the question being put that Bill 87 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 87, *Pay Equity Act*, 2009, was read a second time and ordered referred to the Committee of the Whole House.

The Order being read for second reading of Bill 83, *Loan Act* 2009, a debate arose thereon.

And the debate being ended, and the question being put that Bill 83 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 83, *Loan Act 2009*, was read a second time and ordered referred to the Committee of the Whole House.

The Order being read for second reading of Bill 58, *An Act to Amend the Crown Lands and Forests Act,* a debate arose thereon.

And the debate being ended, and the question being put that Bill 58 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 58, *An Act to Amend the Crown Lands and Forests Act*, was read a second time and ordered referred to the Committee of the Whole House.

The Order being read for second reading of Bill 76, *An Act to Amend the Mining Act*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 76 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 76, *An Act to Amend the Mining Act*, was read a second time and ordered referred to the Committee of the Whole House.

At 12.30 o'clock p.m., Mr. Fraser, the Deputy Speaker, left the chair, to resume again at 2 o'clock p.m.

Accordingly, Bill 93, *An Act to Amend the Medical Services Payment Act*, was read a second time and ordered referred to the Committee of the Whole House.

And after some time, Mr. Fraser, the Deputy Speaker resumed the chair as Acting Speaker. Mr. Fraser confirmed with the House that there was unanimous consent for Bills 58, 76, 83, and 87 to have been considered in Committee of the Whole.
