Due to the unavoidable absence of Mr. Speaker, Mr. Fraser, the Deputy Speaker, took the chair as Acting Speaker.

Mr. MacDonald, Member for York North, laid upon the table of the House a petition on behalf of residents of the York North area urging the government to reverse its decision of Government Garage closures. (Petition 92)

Mr. Williams, Member for Kent South, laid upon the table of the House a petition on behalf of residents of the Kings County area urging the government to reverse its decision to cut the Norton government garage to a winter-only operation. (Petition 93)

Hon. Mr. Lamrock, Acting Government House Leader, announced that it was the intention of government that Bills 78 and 79 be called for second reading; following which, the said Bills would be considered in Committee of the Whole. Bills 80, 81, 82 and 89 would then be called for second reading; following which, the said Bills would be considered in Committee of the Whole.

The following Bills were read a third time:

Bill 35, An Act to Amend the Nursing Homes Act.

Bill 44, An Act to Amend the Small Business Investor Tax Credit Act.

Bill 66, An Act to Repeal the Small Claims Act.

Bill 67, An Act to Amend the Provincial Offences Procedure Act.

Bill 91, Safer Communities and Neighbourhoods Act.

Bill 94, An Act Respecting Expenditure Restraint.

Ordered that the said Bills do pass.

The Order being read for second reading of Bill 78, *An Act to Amend the Credit Unions Act*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 78 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 78, *An Act to Amend the Credit Unions Act*, was read a second time and ordered referred to the Committee of the Whole House.

The Order being read for second reading of Bill 79, *An Act to Amend the Securities Act*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 79 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 79, *An Act to Amend the Securities Act*, was read a second time and ordered referred to the Committee of the Whole House.

It was agreed by unanimous consent that Bills 78 and 79 be considered in Committee of the Whole forthwith.

The House resolved itself into a Committee of the Whole with Ms. Robichaud in the chair.

And after some time, Mr. Fraser, the Deputy Speaker, resumed the chair and Ms. Robichaud, the Chair, after requesting that the Deputy Speaker revert to Presentations of Committee Reports, reported:

That the Committee had directed that she report the following Bills as agreed to:

Bill 78, An Act to Amend the Credit Unions Act. Bill 79, An Act to Amend the Securities Act.

And the Committee asked leave to make a further report.

Pursuant to Standing Rule 78.1, the Deputy Speaker put the question on the motion deemed to be before the House, that the report be concurred in, and it was resolved in the affirmative.

The Order being read for second reading of Bill 81, *Condominium Property Act*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 81 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 81, *Condominium Property Act*, was read a second time and ordered referred to the Committee of the Whole House.

It was agreed by unanimous consent that the House recess at 12.30 o'clock p.m., and resume at 2 o'clock p.m.

The Order being read for second reading of Bill 89, *Right to Information and Protection of Privacy Act*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 89 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 89, *Right to Information and Protection of Privacy Act*, was read a second time and ordered referred to the Committee of the Whole House.

At 12.30 o'clock p.m., Mr. Fraser, the Deputy Speaker, left the chair to resume again at 2 o'clock p.m.
