At 2.56 o'clock p.m., Mr. Speaker declared a recess and left the chair.

3.07 o'clock p.m.

Mr. Speaker resumed the chair.

Mr. B. LeBlanc gave Notice of Motion 62 that on Friday, April 9, 2010, he would move the following resolution, seconded by Mr. Fraser:

WHEREAS Route 11 is part of the National Highway System; and

WHEREAS Route 11 is included in the Atlantic Canada Transportation Strategy; and

WHEREAS efficient movement of goods and service on Route 11 is very important to economic development of northern New Brunswick; and

WHEREAS the current two-lane Route 11 cannot as effectively promote economic growth in northern New Brunswick; and

WHEREAS strategic development of ports and major economic opportunities require modern, four-lane highway support;

BE IT RESOLVED that this Legislature unanimously call upon the federal government to partner with New Brunswick in upgrading Route 11 into a four-lane highway.

Hon. Mr. Byrne, Government House Leader, announced that it was the intention of government that Bills 37, 38, 49, 40, 45, 35 and 26 be called for second reading; following which, the House would resolve itself into a Committee of the Whole to consider Bills 36, 43, 39, 22, 31, 32 and 33.

The Order being read for second reading of Bill 37, *Civil Forfeiture Act*, a debate arose thereon.

And after some time, due to the unavoidable absence of Mr. Speaker, Mr. Fraser, the Deputy Speaker, took the chair as Acting Speaker.

And after some further time, Mr. Speaker resumed the chair.

And the debate being ended, and the question being put that Bill 37 be now read a second time, it was resolved in the affirmative on the following recorded division:
