Mr. Speaker paid tribute to the memory of Donald H. Farnell, a former commissioner at the Legislative Assembly, who lost his life in a tragic accident July 11, 2010.

Pursuant to subsection 16(2) of the *Auditor General Act*, Mr. Speaker laid upon the table of the House the *Auditor's Report on the Accounts of the Auditor General of the Province of New Brunswick for the fiscal year ended March 31, 2010*.

THAT an address be presented to His Honour the Lieutenant-Governor, praying that he cause to be laid upon the table of the House a list of the names, job titles, job descriptions and remuneration of all persons hired by the Province on a contract, term, casual, part-time or full-time basis since October 12, 2010, including all parts of the civil service and crown corporations, boards, agencies and commissions.

Mr. Albert gave Notice of Motion 2 that on Thursday, December 2, 2010, he would move the following resolution, seconded by Mr. D. Landry:

THAT an address be presented to His Honour the Lieutenant-Governor, praying that he cause to be laid upon the table of the House a list of the names, job descriptions, job titles, and departments of all persons whose employment was terminated, whose casual positions ended, or whose contracts were not renewed with the province of New Brunswick since October 12, 2010.
