Following the joint session, the Committee met to review the activities of the Research and Productivity Council for the fiscal years 2008-2009 and 2009-2010.

On February 2, 2011, the Committee met in the Legislative Council Chamber to review the activities and financial statements of the New Brunswick Insurance Board for the years 2008 and 2009. On February 3, 2011, the Committee held an *in camera* orientation session with staff of the Office of the Auditor General. In a letter dated April 11, 2011, Mr. Bill Levesque, Deputy Minister of the Department of Business New Brunswick, provided the following response:

Please be advised that the documents in response to the above noted motion cannot be released as such information is subject to Cabinet privilege. Furthermore, such information would be exempted from disclosure under the provisions of the Right to information and Protection of Privacy Act. In particular discussion papers, policy analyses, advice and briefing materials are precluded from disclosure under paragraph 17(1)(b) of the Right to Information and Protection of Privacy Act. Additionally, information may not be disclosed under the authority of paragraph 26(1)(a) where the disclosure could reveal advice, opinions, proposals or recommendations developed by a government department. Paragraphs 17(1)(b) and 26(1)(a) read as follows: **17(1)** The head of a public body shall refuse to disclose to an applicant information that would reveal the substance of deliberations of the Executive Council, including but not limited to,

[...]

(b) discussion papers, policy analyses, proposals, memorandums, advice or similar briefing material submitted or prepared for submission to the Executive Council,

"26(1) The head of a public body may refuse to disclose information to an applicant if disclosure could reasonably be expected to reveal

(a) advice, opinions, proposals or recommendations developed by or for the public body or a Minister of the Crown,"

THAT an address be presented to His Honour the Lieutenant-Governor, praying that he cause to be laid upon the table of the House a list of all programs, staff, and services cut by each school district to achieve its budgetary reduction targets, including but not limited to any staff dismissed or whose work hours have been reduced; a list of all positions and programs reduced in scope or eliminated; all reductions of expenditures for equipment and supplies, and a complete list of all other measures undertaken to achieve the budget reduction targets in this fiscal year.

Pursuant to Standing Rule 44(4), Mr. Fraser, Opposition House Leader, gave notice that on Thursday, June 9, 2011, Opposition Members' Business would be considered in the following order: Motion 90, 92 and 91.

It was agreed by unanimous consent to dispense with notice and permit Motion 92 to be moved on Thursday, June 9, 2011.

With leave of the House, Hon. P. Robichaud, seconded by Mr. Boudreau, moved: (Motion 95)

WHEREAS New Brunswick took on a leadership role within Confederation by becoming the only officially bilingual province in Canada;

WHEREAS official bilingualism has had a profound and positive influence on New Brunswick's development and has guided our province's cultural, social and political growth;

WHEREAS the government remains committed to official bilingualism and the development of the two official linguistic communities of New Brunswick, as well as to the principles and objectives of the *Official Languages Act*;

WHEREAS the government wants to provide an opportunity for all New Brunswickers to give their views and provide comments during the revision process of the *Official Languages Act*;

BE IT THEREFORE RESOLVED that this House appoint a Select Committee on the Revision of the *Official Languages Act*, to oversee the examination of and consultation on the Act, to review legal decisions, recommendations of the Office of the Commissioner of Official Languages as well as suggestions and recommendations from civil society and New Brunswickers, and to file with the Legislative Assembly an interim report and a final report with recommendations.

In addition to the powers traditionally conferred upon the said committee by the Standing Rules, the Committee shall have the following additional powers:

• to meet during sittings of the House and during the recess after prorogation until the next following session;

- to adjourn from place to place as may be convenient;
- to conduct consultations as it sees fit;
- to retain such personnel as may be required to assist the committee;

BE IT FURTHER RESOLVED that, during a period when the Legislative Assembly is adjourned or prorogued, the Committee may release a report by depositing a copy with the Clerk of the Legislative Assembly, and upon the resumption of the sittings of the House, the Chair shall present the report to the Legislative Assembly;

BE IT FURTHER RESOLVED that the said Committee be comprised of Hon. Ms. Blais, Hon. Ms. Blaney, Mr. Riordon, Ms. Lynch, Mr. McLean, Mr. Bonenfant, Mr. Davis, Mr. C. Landry, Mr. Albert, Mr. Collins, and Mr. Haché.
