## OPPOSITION MEMBERS' MOTIONS

### *Debatable Motions*

**Motion 90 by Mr. Fraser**, seconded by Mr. Collins to propose the following resolution on Thursday, June 9, 2011:

WHEREAS when in Opposition, the now Premier and the now Minister of Health both demanded the purchase of 3T MRIs to be placed in hospitals throughout the province, including locations such as Edmundston, Bathurst and Miramichi;

WHEREAS now that they are in government, the Premier and the Minister of Health have reversed their endorsements of 3T machines and will not be purchasing any for any hospital in New Brunswick;

WHEREAS doctors at the Moncton City Hospital and Saint John Regional Hospital are united in their stance that their hospitals, as major trauma centres and the only two neurological Centres of Excellence in the province, require 3T machines;

WHEREAS the Moncton City Hospital and the Saint John Regional Hospital provide specialty services to New Brunswickers from all parts of the province;

WHEREAS it is vitally important to give our medical professionals the equipment and tools they need to make the most accurate and timely diagnosis and provide the best treatment possible to patients in the health care system;

WHEREAS various expert reports, including the Canadian Agency for Drugs and Technologies in Health report, indicate that the 3T machine is preferred over the 1.5 machine in advanced neurological applications;

BE IT THEREFORE RESOLVED that the Legislature urge the government to change its decision and purchase 3T machines for Moncton City Hospital and the Saint John Regional Hospital.

**Motion 92 by Mr. Collins**, seconded by Mr. Melanson to propose the following resolution on Thursday, June 9, 2011:

WHEREAS the Maeng family of Moncton has lived in Canada since 2003, operating a business, contributing to the economy and paying taxes;

WHEREAS Citizenship and Immigration Canada has denied an extension of the family's temporary resident permit, effectively deporting the family to South Korea, due to the youngest son's medical conditions;

WHEREAS the members of the New Brunswick Legislative Assembly firmly believe that immigration is a key factor in growing our population and, therefore, our economy;

WHEREAS the people of New Brunswick believe in a just society and protection of the most vulnerable;

WHEREAS the actions taken by CIC are unwarranted, cold-hearted and morally wrong;

BE IT THEREFORE RESOLVED that the Legislature urge the provincial government to lobby the federal Department of Citizenship and Immigration Canada to reverse its decision to deny the extension of the Maeng family's temporary resident permit.

**Motion 91 by Mr. Collins**, seconded by Mr. Melanson to propose the following resolution on Thursday, June 9, 2011:

WHEREAS the Alward government is proposing a two-tiered minimum wage for the province of New Brunswick;

AND WHEREAS the Minister of Post-Secondary Education, Training and Labour has refused to engage in meaningful consultation with many of the stakeholders who would be directly affected by such a change in the minimum wage system;

AND WHEREAS a two-tiered minimum wage is a direct attack on the most vulnerable wage earners;

AND WHEREAS the Alward government has shown a double standard by creating high paying patronage appointments for people who were on the Tory campaign bus while at the same time trying to cut the wages of the lowest income earners;

AND WHEREAS a two-tiered minimum wage will give rise to discrimination of many members of society including women and youth;

BE IT THEREFORE RESOLVED that the Legislative Assembly call on the government of New Brunswick to reject any move to establish a two-tiered minimum wage for New Brunswick.

**Motion 10 by Mr. Kenny**, seconded by Mr. Arseneault to propose the following resolution on Thursday, December 9, 2010:

WHEREAS the Point Lepreau refurbishment project is three years behind schedule and \$1 billion over budget;

WHEREAS the refurbishment contract was signed by the former Progressive Conservative government in 2006;

WHEREAS the delays in the refurbishment project require the province of New Brunswick to purchase electricity from other jurisdictions at a cost of approximately \$1 million a day;

WHEREAS the Minister of Energy has stated in this House that his government will accept nothing less than full compensation from the government of Canada for the cost of replacement electricity;

WHEREAS the Prime Minister of Canada has stated publicly that the federal government will only honour its contractual obligations in the refurbishment project;

BE IT THEREFORE RESOLVED that the Legislative Assembly call on the government of New Brunswick to demand from the federal government full compensation of the cost of replacement power resulting from the delay in the refurbishment project at Point Lepreau, for the good of all New Brunswickers.

**Amendment moved by Hon. Mr. Leonard, seconded by Hon. Mr. P. Robichaud that Motion 10 be amended as follows:**

**In the first whereas clause insert the words “projected to be” before the words “\$1 billion over budget”;**

**By replacing the second whereas clause with: “WHEREAS these delays took place under the former Liberal government’s watch;”**

**In the third whereas clause, by deleting the words “purchase electricity from other jurisdictions at a cost” and replacing them with “incur overall project overrun costs”;**

**In the fourth whereas clause by replacing the words “cost of replacement electricity” with “project cost overruns”;**

**By deleting the fifth whereas clause;**

**By replacing the words “of the cost of replacement power” with “for the project cost overruns” in the resolution clause.**

***[Debate interrupted due to expiration of time.]***

**Motion 82 by Mr. Collins**, seconded by Mr. Melanson to propose the following resolution on Thursday, May 12, 2011:

WHEREAS economic experts agree that New Brunswick’s population needs to grow to improve the province’s fiscal outlook;

WHEREAS from 1999 to 2006, New Brunswick’s population was in a steady decline;

WHEREAS the former Liberal government created a Population Growth Secretariat to reverse the trend of out migration;

WHEREAS the Population Growth Secretariat was successful in growing the population by 6,000 people between 2006 and 2010;

WHEREAS the current Conservative government has eliminated the Population Growth Secretariat;

WHEREAS the Opposition strongly believes that population growth is an important factor in improving the province’s economic outlook, and by eliminating the secretariat, this Conservative government has indicated that population growth is no longer a priority;

**BE IT RESOLVED** that the House urge the government to reinstate the Population Growth Secretariat to demonstrate its commitment to making population growth a priority.

**Amendment moved by Hon. Ms. Coulombe, seconded by Hon. Mr. P. Robichaud that Motion 82 be amended as follows:**

**By deleting the second and fifth WHEREAS clauses;**

**In the third WHEREAS clause, by deleting the words “former Liberal”;**

**In the fourth WHEREAS clause, by adding the words “New Brunswick, with the support of ” before the words “the Population Growth Secretariat” and a comma after these words;**

**In the sixth WHEREAS clause, by deleting the words “the Opposition ” and replacing it with “this House ”, and by deleting all the words following “outlook”;**

**By adding the following clause before the resolution clause:**

**“WHEREAS the current Progressive Conservative government incorporated the Population Growth Secretariat as a division within the Department of Post-secondary Education, Training and Labour to create efficiencies and synergies in such areas as employment, post-secondary education, and labour;”;**

**In the resolution clause, by replacing the words “reinstate the Population Growth Secretariat to demonstrate its” with “continue its ongoing”.**

***[Debate interrupted due to expiration of time.]***

**Motion 83 by Mr. Bernard LeBlanc**, seconded by Mr. Kenny to propose the following resolution on Thursday, May 12, 2011:

WHEREAS, in the past, seniors whose wages were not sufficient to pay the full cost of nursing home care were required to sell their property and use their assets in order to pay the cost of their long-term care;

WHEREAS the policy requiring them to sell their property and use their assets in order to pay nursing home costs left many seniors in poverty, since they had to support their spouses in nursing homes;

WHEREAS, currently, the value of a senior's home and other property and assets are not included in calculating the long-term care contribution;

WHEREAS seniors had peace of mind, because their property and assets were protected from the financial assessments used to calculate the costs of long-term nursing home care;

BE IT RESOLVED that the House urge the government to assure seniors that the calculation relating to their long-term care continues to exclude the value of their homes as well as their other property and assets.

**Amendment moved by Hon. Ms. Stultz, seconded by Hon. Mr. P. Robichaud that Motion 83 be amended as follows:**

**In the first WHEREAS clause by deleting the words after "in the past," and replacing them with "seniors' assets were considered when determining their contribution towards the cost of their long term care services";**

**In the second WHEREAS clause, by deleting the words "them to sell their property and use their assets in order to pay nursing home costs" and replacing them with "assets to be considered in the calculation of the contribution towards the costs of nursing home care".**

**Motion 88 by Mr. Collins**, seconded by Mr. Melanson to propose the following resolution on Thursday, June 2, 2011:

WHEREAS the opening of the causeway gates in the Petitcodiac River by the previous Liberal government was an important step in correcting an environmental disaster;

WHEREAS the Petitcodiac Riverkeepers, L'Alliance du Bassin Versant and other organizations are currently monitoring the river and planning the next steps in the restoration process;

WHEREAS certain members of the Conservative caucus have expressed their desire to see the restoration project halted;

WHEREAS the Conservative government has cut funding through the Environmental Trust Fund to the Petitcodiac Riverkeepers, L'Alliance du Bassin Versant and other groups involved in the monitoring and restoration of the river;

BE IT THEREFORE RESOLVED that the Legislature urge the government of New Brunswick to reinstate funding to the Petitcodiac Riverkeepers and other environmental organizations working on this important project.
