Mr. M. LeBlanc rose on a point of order and submitted that he had been defamed by comments made on a social media platform by Hon. Mr. Fitch. Mr. Speaker took the matter under advisement.

And the debate being ended, and the question being put that Bill 35 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 35, *An Act to Amend the Financial Administration Act*, was read a second time and ordered referred to the Standing Committee on Economic Policy, as designated by the Government House Leader.

The Order being read for second reading of Bill 36, *An Act to Amend the Motor Vehicle Act*, a debate arose thereon.

At 12 p.m. the House recessed. At 1 p.m. the House resumed.

Mr. Speaker delivered the following ruling:

STATEMENT BY SPEAKER

Honourable Members,

Earlier today, the Member for Restigouche-Chaleur raised a point of order and submitted that the Minister of Health defamed him on Twitter. Specifically, the tweet in question alleged that the Member for Restigouche-Chaleur laughed at the Minister of Health's attempt to speak French. The Member for Restigouche-Chaleur denies this allegation, and I will take him at his word that he did not engage in the alleged conduct.

With that said, however, I must advise the House that the Speaker does not have the authority to address comments or statements made outside of the House. As well, it would be impractical for the Speaker to be asked to monitor the use of personal digital devices by Members, including determining whether any offending tweet or social media post originated in the House.

I will address, however, the general issue of tweeting or posting items on social media. I would ask all Members to please refrain from tweeting or posting criticism of your fellow Members on social media while we are sitting in the House. To engage in such activity would obviously cause disorder in the House, lead to various points of order, distract from the business of the House, and undermine the reputation of this House and its honourable Members. I thank you for your attention to this matter. I hope that you follow my request. It would make it a lot easier for all of us, and we could have the next 13 days in some form of peace.

Debate resumed.

And after some time, Mr. Arseneau, seconded by Mr. Coon, moved in amendment:

AMENDMENT

THAT the motion for second reading be amended by deleting all the words after the word "that" and substituting the following:

"Bill 36, *An Act to Amend the Motor Vehicle Act*, be not now read a second time but that the order for second reading be discharged and the subject matter of the Bill referred to the Standing Committee on Law Amendments."

Mr. Speaker put the question on the proposed amendment and a debate ensued.

And the debate being ended, and the question being put on the amendment, it was resolved in the negative.

And the question being put that Bill 36 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 36, *An Act to Amend the Motor Vehicle Act*, was read a second time and ordered referred to the Standing Committee on Economic Policy, as designated by the Government House Leader.

The Order being read for second reading of Bill 37, *An Act to Amend the Salvage Dealers Licensing Act*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 37 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 37, *An Act to Amend the Salvage Dealers Licensing Act*, was read a second time and ordered referred to the Standing Committee on Economic Policy, as designated by the Government House Leader.

The Order being read for second reading of Bill 41, *An Act to Amend the Private Occupational Training Act*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 41 be now read a second time, it was resolved in the affirmative.

The Order being read for second reading of Bill 39, *Justices of the Peace Act*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 39 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 39, *Justices of the Peace Act*, was read a second time and ordered referred to the Standing Committee on Economic Policy, as designated by the Government House Leader.

The Order being read for second reading of Bill 40, *An Act Respecting Hearing Officers*, a debate arose thereon.

And the debate being ended, and the question being put that Bill 40 be now read a second time, it was resolved in the affirmative.

Accordingly, Bill 40, *An Act Respecting Hearing Officers*, was read a second time and ordered referred to the Standing Committee on Economic Policy, as designated by the Government House Leader.
