Executive Summary

This is the eighth annual report for the Midwifery Council of New Brunswick/Conseil de l'Ordre des sages-femmes du Nouveau-Brunswick (MCNB) and captures the work and activities of the Council between **April 1**st, **2023** – **March 31**st, **2024**.

The primary activities of the MCNB were;

- Appearing before the Standing Committee on Public Accounts.
- Continued involvement with the Canadian Midwifery Regulators Council (CMRC) and committees.
- Continued collaboration and engagement with the New Brunswick Health Professions Regulatory Network (NBPRN).
- Registration and renewal of registration of midwives.

The Midwifery Council met 6 times this year. The Council meetings ran an average length of 85 minutes and included the Annual General Meeting in May 2023 and engagement in an Equity, Diversity, and Inclusion workshop in June 2023.

Midwifery Beyond a Pilot Project

The *Midwifery Act* was proclaimed and came into force on August 12th, 2010. The implementation of midwifery began with one practice in Fredericton in 2017 and has since remained a pilot project for 7 years.

In 2021, the Department of Health announced the evaluation of the Fredericton Midwifery Program via a third party. A report was expected in mid-2022.

In the summer of 2023, a summary of the evaluation report was received by MCNB noting positive results, however, the full report has not been provided.

On September 6th, 2023, MCNB appeared before the Legislative Assembly's Standing Committee on Public Accounts with Kelly Ebbett Executive Director/Registrar, Bruce Robinson, Chair and Ursula Rinne, midwife member representing the Council.

On March 19th, 2024, Government included in their announcement of the upcoming 2024-25 budget, funding of \$562,000 to expand midwifery services.

MCNB is encouraged by the announcement, however, we have not had any discussions with the Department of Health or know what the intention is for where the pilot project stands. We do not know of the status of the evaluation report.

We remain ready and willing to assist the Department in any way it sees fit in bringing conclusion to the pilot and establishing Midwifery practice fully in New Brunswick.


1 complaint was received and investigated. No additional action was required by the Discipline Committee for hearing or determination.

Notes to Compiled Financial Information

For the Year Ended March 31, 2024

1. Purpose of the organization

The Midwifery Council was established as per the Midwifery Act. Its purpose is to regulate the practice of Registered Midwives in the province of New Brunswick. The organization is registered as a not-for-profit organization under the Income Tax Act, and as such, is exempt from income taxes.

2. Basis of accounting

The basis of accounting applied in the preparation of the statement of financial position of the Midwifery Council of New Brunswick/Conseil de l'Ordre des sages-femmes du Nouveau-Brunswick as at March 31, 2024 and the statements of operations and changes in net assets for the year then ended is the historical cost basis and reflects cash transactions with the addition of:

- Accounts receivable less an allowance for doubtful accounts;
- Property, plant and equipment recorded at historical cost and amortized on a declining balance
- Accounts payable and accrued liabilities;
- Investments recorded at cost
- Prepaid expenses
